

Low-Carbon Energy Tracking of UPR

The energy consumed by University of Poonch Rawalakot (UPR) primarily stems from hydropower sources. The low carbon energy consumed is 100 % from hydropower. The breakdown of this calculation is outlined below.

Electric Power Consumption and Hydroelectricity Dominance: University of Poonch Rawalakot's 2022 Overview

The University of Poonch Rawalakot consumed a total of 763 Giga Joules of electric power (copy attached) from January to December 2022. The energy consumption for every building within the university is accurately computed and displayed in a clear tabulated layout. The primary source of this energy was derived from hydroelectricity, reflecting the region's reliance on completed hydroelectric projects in Azad Jammu and Kashmir.
