- i. Forgraduation, the minimum qualifying C.GPA is 2.00/4.00 for Bachelors and 2.5/4.00 for Masters Students.
- ii. Wheneveran undergraduatestudent's C.GPA decreases from a specifiedthreshold in a on"1stProbation"for the next semester.Ifthe be will semester then,he/she studentdoesnotachieve required specified CGPA in next semester, the "Last Probation". on will go Ifthestudentwhowasearlieron" LastProbation", does not come out by achieving the minimum sp ecifiedC.GPA in the subsequent semester, the student will be "Relegated" to previous semester and allowed to repeat the whole semester (last attended) once only by sitting with the students of junior session. Thereafter, If still he/shefails to achieve the required CGPA he/she shall be dropped from the Institute. The required/threshold CGPA for each semester, in undergraduate degree programis given below in Table 1.For a graduate degree program (2 years), a student will be on "1st Probation" if he/she is unable to attain the required CGPA in a semester and will go on "Last Probation", if he/she does not attain the required CGPA in the next semester. If the student, who was earlier on "Last Probation", does not come out by achieving the minimum specified CGPA in the subsequent semester, the student will be dropped from the University Rolls. Table 2 given below, explains the required/threshold CGPA for each semester, in graduate degree program. Table 1 and Table 2 clearly shows the number of probations, specified/required minimum CGPA of each semester, number of probations for undergraduate and graduate degree programs, respectively.

iii. The relegated student will wait for a semester so that the junior session will reach the semester in which he/she has been relegated, in the meantime the student can repeat the

failed courses offered by the faculty (i.e., no special course will be offered).
